A MESSAGE FROM THE
CHAIRMAN**

Dear Members,

Every time when I am requested for my contribution to the newsletter I can never think of what needs to be said. I tend to repeat the same doe's and don'ts and try to include anything new or important messages to get across, so I expect this one will follow the same format. So perhaps I should start with the usual formalities of extending a warm welcome to a new season of fishing activities for all those existing members and the new ones joining us for the first time this year.

To begin with, many thanks to all those who attended this years A.G.M. a very good turn out once again, I am not sure if everybody understood the

special announcement on the night and what it means to the Society.

Firstly we now have a valuable asset giving more financial credibility. Secondly, the gift of land with the two waters means that the fish stocks will always remain in the ownership of the Society as this is not always the case on rented waters. finally, had this area of land been included in the sale of the farm we would have had to pay rent, so my sincere thanks on behalf of the Society to the previous owners for considering us at the time of negotiations for the sale.

Stocking Kessingland has been delayed until the Autumn. Briefly, health checks delayed the order in the first place then some of the stock are obtained from Eastern Europe and E.E.c. regulations got in the way. Finally, the driver of the transport broke his back in an accident so with the temperature rising it became too late to move them.

Day membership sales were down last year, one reason being we had reduced them to a more manageable level which relieved us of some of the previous problems. All round this seems to suit our club. We also introduced the Guest Membership Ticket scheme so that members could fish our waters with other members of their family or friends who are not members. Some I know consider these expensive but where could you go that allows a person to fish from dawn to dusk (on some days 18 hours) visiting as many Society waters as he wants, with an accompanying Society Member, on any one of the seven days of the week.

Now for some of the does and don'ts. Security is one of the most important areas to put high on your priority list these days. Security for yourself personally where any water is involved. Security in always locking your car, never leave your gear unattended. Security in ensuring all gates and premises of the Society are secure at all times.

Always take all rubbish away, never leave hooks or line behind, unfortunately angling is always getting a bashing so do not allow anybody the opportunity to criticise. observe the rules of the Society at all times which includes consideration of others as well.

Enjoy your fishing, your help and assistance is always appreciated where it is possible to give it. I hope the match fishing events are attended in numbers and I wish you all good luck in whatever you wish to pursue.

Comment - George served on the committee for many years before work commitments prevented him continuing. Our thanks go to him for all his efforts and continued support during those early years.

PASSPORT PROBLEMS?

I refer to your order for Coarse fish, which were due to be delivered this season. These fish were part of a large consignment of fish which were to have been imported from a fish farm in Croatia. Fish from this farm have been supplied by Humberside Fisheries without problem since 1976.

However, on this occasion, the Austrian Authorities (through whose border the fish enter the European Community), decided to apply European Legislation concerning food products to this consignment of Coarse fish. The British Government tried to explain that the British do not eat Coarse fish but to no avail.

It was only last month that we finally found a way to import these fish, via Italy, the Italian Government accepting the British do not eat Coarse fish.

Regrettably, the owner driver of the haulage company had a serious road traffic accident only days before he was due to collect the consignment. He is unable to work for a further 4 months. Given the short time available before it becomes too hot to move the fish it has proved impossible to find an alternative company. Therefore I am unable to deliver these fish at this time but am certain I will be able to deliver this autumn.

Comment - Another delay to the development of Kessingland but obviously beyond our control.

KING FISHER TIP **Steamed Bread** - Having put a slice of bread into a plastic bag, allow steam from a boiling kettle into the bag. Check the bread periodically until it becomes sticky and it peels. To use it, separate a strip from the slice and double it around the shank of the hook. Nip it onto the shank leaving the two ends sticking out above the bend of the hook like a "flag". Once in the water the "flag" fluffs up covering the point of the hook but remaining very soft and allowing easy hooking of the fish.

BROADS AUTHORITY - Those of you who may be interested in the future of the Broads may wish to comment on the Draft Broads Plan 2004. This important document is the management plan for the whole of the Broads Authority area which includes our waters on the River Waveney. More Than Catching Fish

Do you ever have a day when you seem to have overcome all adversity and then it all goes pear shaped ?

Another eastern regional Final, this time scheduled for the Great Ouse, but owing to a fish disease being rife in the fens, moved to Shrewsbury. Too far by motorcycle and the train journey being impractical, myself and another local angler decided to pull out. However, in those early days, when car ownership was not the norm, many local anglers were indebted to one of our well known Southwold past members, Mr George Howard, for transport. Rather than have us miss out he offered to take us.

The journey was not for the faint hearted! Leaving at an early hour “low flying” the 230 odd miles across country making just one stop, then running into heavy rain and there we were waiting for the HQ to open.

After a welcome breakfast we were told that owing to heavy rain the river was running feet above normal but as there had been no time to inform us of a cancellation, the match would go ahead.

Drawn in the only section to be pegged above the Welch Bridge, my peg at least 10 feet down a steep rocky bank, no space to put up my umbrella for shelter, and faced with a river more suited to white water rafting, George's remark “Better you than me mister” said it all.

Starting on the lead but losing two bombs in 3 casts it was time for a rethink. Switching to float I could not get the control I needed but I did manage to locate a small eddy hard to the near bank downstream where by casting direct and holding the line off the water I could hold for a few seconds before being swept out by the real rush of water. Catching my first fish, a Ruffe, it was then cast and recast to finish with seven Ruffe and three Dace.


Cold and more than a bit damp I sheltered in the warm car waiting to be weighed in, but with George, who had acted as “runner” all day, telling me that mine were the only fish caught above the bridge and apart from two anglers pegged in the lee of a bend downstream, there was just the odd fish caught, it all seemed worth it.

That was until I handed up my net to be weighed in and my hard won Ruffe “flew” over my head one by one back into the river with the stewards

explaining that Pike, Eels and Ruffe were “out” on the day!

Then back at HQ we found my Dace, having weighed twelve and a half ounces were just one and a half ounces short of qualifying for the National Final.

There you go, some you win, and well, at least I'd been fishing.

County News

Suffolk County continues to face a challenging future with no interest being expressed in taking on the duty of General Secretary. In his last year as County Chairman, John Purdy is continuing to cover the secretaries duties with the assistance of Match Secretary Andy Wilson-Sutter and Treasurer Barry Reid.

Communications with member clubs has been significantly improved resulting in many that were considering leaving the County recognising that positive steps are being taken to respond to previous criticisms.

A survey is currently being undertaken to establish the number of members each member club has and if they are members of the NFA in their own right. The NFA have been made aware of this.

John Purdy has ensured that the County and its events are properly insured (including the sea section) but it is a condition of the insurance that all members are given a copy of the notice as reproduced below. This covers our use of Bungay Common as affiliated members of Suffolk County AAA.

The need to be a member of such an umbrella organisation has never been greater. As if to prove the point, I was recently asked to take part in a live Radio Suffolk interview in respect of the “fish feel pain” debate. Having been able to obtain a great deal of help / information from the NFA. I was well prepared for the interview resulting in the interviewer having to change his line of attack completely as he wasn't winning.

The draft Broads action plan is currently out for consultation and I am sure the County will be making comments on your behalf so please give us any feedback you have.

It is likely that the County will play an increasingly important role within ACANS to help it meet its own challenge of adequately representing anglers over a very large geographical area.
A busy year ahead but hopefully it will become easier as things are sorted out.

SUFFOLK COUNTY A.A.A CIVIL LIABILITY (THIRD PARTY) INSURANCE

Most members will be aware that the Suffolk County Amalgamated Angling Association has liability insurance cover for all paid up members with an indemnity of £2m and which covers such members for claims made against them by third parties for personal injury or damage to property arising out of the member's angling activities. Cover includes member to member liability and it also indemnifies day permit (day member) holders. Claims for personal injury or damage arising out of the use of the Associations fisheries are also covered.

From April 1999, the Civil Justice System has changed the manner in which claims are dealt with. These changes are known as the **Woolf Reforms** and their intention is to resolve disputes more quickly and efficiently. Strict timescales are now in place to direct the handling of claims. **Members must**, therefore, report **every** incident, particularly those involving personal injury to the Suffolk County A.A.A. Secretary immediately it happens so that it may be reported in turn to our insurers who will advise us what to do next. We have been advised that we must forward any appropriate documents to the insurers as soon as possible in order to comply with these new timescales.

CONSEQUENCES

If you want our insurers to defend and/or pay the bill you **MUST** play by the rules. If our insurers can legitimately demonstrate that your failure as to time, investigation and or receipt of documents has genuinely prejudiced your defence they may try to:-

Walk away

Pay out and recover from you

Settle as a matter of expediency & considerably increase our premium

Determine that all or part of an award constitutes a penalty and as such is not insured.

PLEASE REMEMBER that the Woolf Reform procedures may also apply to any other liability insurance's, either business or personal that you may hold.

NOTES FROM THE SECRETARY

HERBICIDES - Our Head water Bailiff has reported that on or about the 11th May an as yet unidentified person had sprayed the banks around almost every peg on Buss Creek with a herbicide. Whilst the person who did this probably thought that he / she was helping the Society it must be pointed out that uncontrolled spraying can be very dangerous. There are very few sprays that are suitable for use near water / fish and those that are are very expensive. There are also health and safety and insurance implications. The Committee always welcomes assistance from members but this should ideally be given at organised work parties or otherwise with the direct permission of the Head Water Bailiff, Chairman or Secretary.

GILLINGHAM - Access remains difficult and the decision on whether to keep the venue is still dependant on the farmer significantly improving the situation. In the mean time please take care both when driving to the parking area, walking across the field and adjacent the piled section of river bank. You will notice from the map that the middle section of the river has been given up, however, it is still available for use until 1st September this year.

KESSINGLAND - Vandals have been busy through the closed season and the lock and clasp have had to be replaced twice and the signboard once. Please report anything suspicious, remember to take car registrations and report to Head Water Bailiff or Secretary asap.

DONATIONS - The Committee would like to thank those of you that gave donations in addition to paying your annual subscriptions. Over £250.00 has been received and it gives great encouragement to Committee members as it is a clear indication that their work is appreciated.

WORK PARTY VOUCHERS - I must at this point apologise for not issuing last years vouchers. I will try to send these out shortly with those for this year. They can be used for next years subs or if returned to the membership secretary I will arrange for repayment of the equivalent amounts from this years subs. Many thanks for your continued help on the work parties.
