### **Message from the Chairman**

#### **Final otter fencing**

As another new season approaches we can start to look forward to reaping the rewards of the tremendous amount of support and hard work put in over the last two years. The fund raising efforts and careful financial management has meant that just under £30,000 has been raised and spent providing otter proof fencing at the Reydon complex.

The final section of fencing will see Sherwood Water protected, sometime around the start of the season, and complete the fencing phase of the project. This work has not been carried out in isolation as the opportunity to introduce additional stock has been taken each time a lake has been secured. Kingfisher (2), Paisleys (3) and Denny Lakes (4) have all received new stock but now that the fencing is completed, the committee can concentrate on finishing off the stocking of the complex.

#### **Weed Control**

Although we all look forward to a better summer than last year, it can bring its own problems. Hopefully the healthy water levels will be maintained but we wait with baited breath to see how successful the addition of a water dye will be in holding back the growth of weed in Denny Lake and Paisleys Pond. Manual intervention may also be necessary so please try to support the work parties run by Head Water Bailiff Jed Gerrell.

### **Remember the rivers**

We mustn't forget that whilst the Reydon complex is the jewel in the crown, the Society has always tried to provide a full range of types of fishing across the whole catchment area of the Society.

We continue to hold two sections of the River Waveney, one tidal and one non tidal, to provide the opportunity to fish moving water and target species such as pike, chub, roach, dace and chub.

### **Kessingland**

We also have the lake at Kessingland which is ideally located between Lowestoft and Southwold. This has been a challenging venue to get right but does benefit from having a very supportive owner whose own efforts mean that maintenance by the Society is kept to a minimum. It has become clear that stocking the water once and then leaving it for several doesn't work. The owner understands the challenges of predation and the society has negotiated a deal which includes an element of fish stocking every year as part of the agreement. This effectively reduces the annual rent we pay and ensures a regular top up of fish which will hopefully help the stock build up. I was very pleased that the annual general meeting supported this approach and look forward to improved fishing at the venue. To that end, approximately 550 carp (8 to 12 inches) were introduced earlier this year and this will be built on each winter.

### **Juniors, matches and donations**

Moving on to the match scene, the committee were particularly pleased that the society was able to reintroduce some junior matches last season. This was given a further boost at the AGM when an unexpected letter was submitted by Jackie Martin, the organiser of the Randolph Hotel Quiz night, along with a cheque for £241 with a suggestion that it be used to support juniors. As a result, the Randolph Trophy will be fished for as part of the junior programme of matches, The winner each year will receive a trophy and a free year's subscription.

Extra stocking will be introduced to Paisleys Pond which has always been developed as a junior water. With support such as this, the completion of the fencing, and a junior committee member (Brer Cornish) I hope that we are not far away from the reintroduction of the Southwold Junior Open, fingers crossed for next year!

### **Senior matches**

#### ***Keep gates locked***

With otter proof fencing in place it is even more important than ever to ensure that all gates are kept closed so please help us to ensure they are.

#### ***Reydon arrival and departure times***

We have had a few complaints about early and late arrivals at the Reydon complex so please remember that fishing is restricted to 1 hour before sunrise and 1 hour after sunset,

#### ***Fish with regard to others***

Our Head Water Bailiff has asked that a reminder be printed that fishing must not be undertaken so as not to disturb the enjoyment of others so please do not fish across other peoples swims (see rule 18).

#### ***Non-fishing guests***

There has been an increase in non-fishing guests visiting Society waters. Landowners only give us permission to fish so please do not encourage this practice as such access is not permitted.
